Revisiting "Poletown and Eminent Domain"

What happened in Hamtramck 28 years ago still reverberates today. Back then, in an effort to bolster Detroit's crumbling economic base, a working-class neighborhood known as Poletown was demolished to make way for a new General Motors plant. This action was challenged by some homeowners and small businesses in the area, but rebuffed by the Michigan Supreme Court in 1981 in a landmark 5–2 decision. This ruling had national ramifications and set a new standard—expanding the power of eminent domain and allowing the definition of public use to include economic development. In 2004, the Court reversed itself.


On Tuesday, December 2, 2008, the State Bar of Michigan will commemorate the 1981 Poletown decision (Poletown Neighborhood Council v Detroit) as part of its Michigan Legal Milestones program, which highlights significant legal cases in our history. A bronze marker will be unveiled at the ceremony, to be held at the Polish National Alliance Council 122, located at 10211 Conant Street in Hamtramck. This plaque will later be permanently installed at Zussman Park

at City Hall in Hamtramck. State Bar President Edward H. Pappas will serve as master of ceremonies at the dedication. Speakers, representing a range of viewpoints, will include some prominent eminent domain attorneys involved in the dispute: Alan Ackerman, Ackerman Ackerman and Dynkowski; Norman Ankers, Honigman Miller Schwartz and Cohn LLP; David Baker Lewis, Lewis and Munday PC; Jerome P. Pesick, Steinhardt Pesick and Cohen PC; and Ron Reosti, Reosti James and Sirlin PC.

Also scheduled to speak are local historian Gregory Kowalski and the Hon. Paul J. Paruk, chief judge 31st District Court, Hamtramck, and a board member of the Detroit Metropolitan Bar Association. The DMBA is partnering with the Bar to present this event. The program begins at 11 a.m. Lunch will be provided.
