Judge On-Line Debuts in Oakland County Circuit Court



As an alternative to face-to-face court hearings, a new pilot teleconferencing program called Judge On-Line has

been launched by the Oakland County Circuit Court. It is designed especially for scheduling, status, and pretrial and settlement conferences, as well as motion hearings and other court proceedings at the discretion of the presiding judge. Parties and attorneys may appear for these court events from work or home and while on vacation for a nonrefundable \$30 convenience fee. Court officials said the new service will save attorneys and litigants travel time and fuel costs and help manage the court docket more effectively. Judges participating in the pilot program are Steven Andrews, Martha Anderson, Rae Lee Chabot, Shalina Kumar, Colleen O'Brien, Edward Sosnick, and Joan Young.

"This is a win-win for the courts and the entire legal community," said Chief Judge Wendy Potts. "Judge On-Line is our initial foray into what will become a full-fledged interactive and state-of-the-art audio and video conferencing program. We want to be sure that parties and attorneys embrace the concept of a 'virtual' court appearance through telephone conferencing. When that happens, it's full steam ahead toward interactive video that will save both litigants and attorneys time and money."

Potts said Judge On-Line will help promote effective docket management by moving cases faster through the system to completion because there will be fewer adjournments due to scheduling conflicts. Oakland County's 19 circuit judges handle more than 30,000 cases annually. Cooley Auburn Hills Expansion Signals Green Days Ahead

Count Thomas M. Cooley Law School among the entities making a commitment to environmental friendliness with the construction of its 67,000-square-foot addition to its existing facility in Auburn Hills.

Among the eco-friendly innovations included in the expansion project is a sedum roof; the plant growth, along with white reflective roofing, will cut cooling costs by allowing the building's temperature to regulate naturally. Natural lighting is emphasized, limiting the use of artificial illumination, and the facility will house a recycling center to eliminate waste. The drywall used in construction is made from a combination of recycled paper and a synthetic byproduct generated by power plants, and nearly 1,400 tons of construction waste will be recycled.

The addition, scheduled for completion in January, will also include a fully functional trial courtroom and a combination classroom/appellate courtroom. The expansion will more than double the size of the Auburn Hills campus and allow the campus's enrollment to increase by more than 300 students.

Atrium Named After Former SBM Executive Director Bachmann

Proudly displaying a plaque honoring his father's achievements, William Bachmann from New York City was at SBM headquarters in Lansing November 14 to take part in a brief dedication ceremony. The atrium in the SBM building has been named after Milton E. Bachmann, an executive director of the State Bar from 1947 to 1970. A resolution in his honor states that he was a dedicated friend to the legal profession and a quiet public servant who devoted countless hours to improve the Bar. The resolution also notes that while serving as SBM executive director,

Milton Bachmann "wore many hats, personally handling grievance cases, making arrangements for the Annual Meeting, editing and supervising the Michigan Bar Journal, visiting with public officials, and working with John W. Cummiskey, then State Bar president, to create the Michigan Lawyers Auxiliary," among other official duties. During Bachmann's tenure, State Bar membership grew from less than 7,000 to more than 11,000. Currently, the Bar has over 40,000 members.
