### Michigan Public Defense System Subject of U.S. House Hearing



On March 26, the United States House of Representatives Committee on Judiciary Subcommittee on Crime, Terrorism, and Homeland Security held a hearing on Representation of Indigent Defendants in Criminal Cases: A Constitutional Crisis in Michigan and Other States? The State Bar of Michigan was represented by two past presidents, Dennis W. Archer and Nancy J. Diehl. The

hearing focused on the growing national crisis to provide effective representation to indigent persons in criminal proceedings, as required under the Constitution. The State Bar is currently working to address the state problems documented in a report released in June 2008, "A Race to the Bottom, Speed and Savings Over Due Process: A Constitutional Crisis." A federal response is being

# Milestone Highlights Case that Gave Rise to the Asian American Civil Rights Movement

The 34th Michigan Legal Milestone is set for Friday, June 19, 2009, at 11 a.m. at the Chinese Community Center in Madison Heights. The center is located at 32585 Concord Drive, south of 14 Mile Road.

The ceremony will commemorate the Vincent Chin case and reflect on its significance in our legal history. Chin's beating death in 1982 in Highland Park and the lenient sentences meted out to his assailants caused an outcry in the Asian American community and led to the birth of a civil and victims' rights movement. A bronze plaque memorializing what occurred will be unveiled at the end of the ceremony. State Bar President Ed Pappas and SBM Executive Director Janet Welch will share the duties of master of ceremonies. Speakers are:

### Pro Bono Attorneys Tackle Increasing Load of Foreclosure Cases

Foreclosure prevention training is in demand. A two-day session in mid-February in Novi attracted 60 attorneys. Over 300 had actually signed up for the 200 available spots. After completing the program, the lawyers were assigned cases and offered the help of law students. As a result of the program, a new roster of trained pro bono lawyers and students has been set up to deal with the increase in foreclosure cases being filed by pro per litigants in federal court. The training project was a result of the combined efforts of the Federal Bar Association for the Eastern District of Michigan, Eastern District Judges Pro Bono Committee, the Michigan

Poverty Law Program, the Thomas M. Cooley Law School Alumni Association, and the State Bar of Michigan. Funding was provided by the Michigan State Bar Foundation, the FBA Eastern District Chapter, the Michigan State Housing Development Authority, and other organizations.
