Foster Swift Attorneys' Steer Donation Feeds Needy Families

Lawyers at Foster Swift Collins & Smith recently managed to do two good deeds at once-supporting community youth activities through 4-H and donating 700 pounds of meat to the Greater Lansing Food Bank. As a 4-H project, Richard Kraus's daughter raised a steer that was named Grand Champion at the Ingham County Fair. A livestock auction is held at the fair's end, with part of the proceeds used to support local youth participating in 4-H activities. Kraus organized a group of attorneys at Foster Swift to contribute the funds needed to win the Grand Champion auction and then donate the meat to the Greater Lansing Food Bank.

After learning that the food bank was equipped only to distribute ground beef, Kraus contacted the competing bidder at the auction, Merendorf Meats & More, and made a deal. Merendorf wanted the chance to sell the steer's restaurant-quality beef to its customers; Foster Swift wanted to make as much meat as possible available to needy families in the community. In return for the Grand Champion, Foster Swift persuaded Merendorf to almost double the amount of meat. As a result, about 700 pounds of ground chuck will be distributed through the food bank rather than the 400 pounds that would have come from the steer.

The first sentence in the article should read: "Until the turn of the last century, Michigan consistently had the highest number of registered boats in the United States, which makes a good deal of sense considering that our state has the longest coast line-3,288 miles bordering the Great Lakes (greater than the length of the Atlantic coast from the top of Maine to Key West)—of any state other than Alaska."
