# Finding Solutions to the Indigent Defense Crisis

The U.S. House Judiciary Committee, chaired by Congressman John Conyers, held a briefing in the morning. A panel discussion covered issues such as the importance of standards in fixing local and national crises, attorney performance and oversight, state funding and supplemental federal money, state court litigation, and easing access to federal courts. During the afternoon session, Representative Mark Meadows convened a hearing of the Michigan House Judiciary Committee to take testimony on HB 5676, a bill to create the Michigan Public Defense Act.

### Michigan Legal Milestone Plaque on Poletown and Eminent Domain Placed

man Park, outside the Hamtramck City Hall, which houses the 33rd District Court. The plague commemorates the 1981 Poletown decision (Poletown Neighborhood Council v Detroit), when, in an effort to bolster Detroit's crumbling economic base, a working-class neighborhood known as Poletown was demolished to make way for a new General Motors plant. This action was challenged by homeowners and small businesses in the area, but was rebuffed by the Michigan Supreme Court in a landmark 1981 decision. The ruling had national ramifications and set a new standard by expanding the power of eminent domain and allowing the definition of public use to include economic development. In 2004, the Court reversed itself (County of Wayne v Hathcock).
