State Bar Representative Assembly Held First Meeting of 2010

The State Bar Representative Assembly kicked off its first meeting of 2010 on March 27 with an address by Michigan Supreme Court Chief Justice Marilyn Kelly. Among other business conducted at the meeting, the RA adopted a recommendation to amend the Rules of Professional Conduct or court rules to prohibit solicitation of clients: "In any matter involving a family law case in a Michigan trial court, a lawyer may not initiate contact or solicit a party for purposes of establishing a client-

lawyer relationship, where the party and lawyer had no pre-existing family or clientlawyer relationship, until the first to occur of the following: service of process upon the party or fourteen (14) days has elapsed from the date of filing of the particular case."

In addition to its official agenda, the RA hosted a food drive to benefit the Greater Lansing Area Food Bank and a fundraiser for the Access to Justice Fund, which supports civil legal aid for low-income people.
