Boosting Diversity in the Legal Profession

The State Bar of Michigan held three colloquia sessions in June to receive input on a draft statement aimed at increasing diversity in the legal profession at Wayne State University Law School in Detroit, Thomas M. Cooley Law School Grand Rapids Campus, and Michigan State University College of Law in East Lansing.

The events were kicked off by SBM Director of Diversity Gregory Conyers and a video welcome by Michigan Supreme Court Chief Justice Marilyn Kelly, who pledged her personal support for the efforts of all involved in the colloquia.

Kelly said the law is lagging far behind many other professions in diversity, with people of color making up only 10 percent of the population of the profession. In comparison, 25 percent of medical doctors, 21 percent of accountants, and 18 percent of college professors are people of color.

"For a profession that prides itself on equal protection under the law, that's a troubling statistic," Chief Justice Kelly said. "If we fail to diversify to reflect the makeup of those we represent, we will face a crisis in trust."

Other leaders involved in the colloquia include SBM President Charles Toy; SBM President-Elect W. Anthony Jenkins; Rodney D. Martin of Warner, Norcross & Judd; and John Nussbaumer, Thomas M. Cooley Law School Auburn Hills associate dean and member of the American Bar Association's Presidential Advisory Council on Diversity in the Legal Profession.

"We hope to release the final document at this year's SBM Annual Meeting in September," Conyers said. "Then we will begin the process of seeking support for this agenda by asking members of the profession to sign on to the document in agreement with its tenets."

MSU Law Professor David S. Favre to Receive ABA Award for Animal Law Work

The Animal Law Committee of the American Bar Association Tort Trial & Insurance Practice Section will honor David S. Favre of East Lansing with its Excellence in the Advancement of Animal Law Award.

Presented annually, the award recognizes exceptional work by a member or leader of an international, national, regional, state, or local bar association's animal law committee who, through commitment and leadership, has advanced the humane treatment of animals.

The award will be presented to Favre on August 7 during the ABA Annual Meeting in San Francisco. Favre has been at Michigan State University College of Law since 1976. He teaches courses in animal law, international environmental law, property, and wildlife law. He has written several articles and books dealing with animal issues covering topics such as animal cruelty, wildlife law, the use of animals for scientific research, and international control of animal trade. His books include Animal Law and Dog Behavior; Animal Law: Welfare, Interest, and Rights; and International Trade in Endangered Species. He also has presented to international audiences on these topics.
