"Professionalism in Action" Gathering Momentum

The State Bar's Professionalism in Action program, inaugurated last year at Thomas M. Cooley Law School's Auburn Hills campus, has been gathering momentum. Because of the dedication of the volunteer members of the SBM Disabilities Workgroup, the newsletter has continued on a quarterly basis since its launch.

Each newsletter tackles a specific topic such as "Autism and the Courts" and "Accommodating a Person with a Visual Disability in the Courts" and contains concise and helpful information for attorneys, judges, litigants, witnesses, jurors, and the general public.

The newsletter, which began with approximately 400 subscribers, now has a subscriber count of 739.
