### Remembering Mrs. McCree

ach April for many years, Dores McCree would make the trek from Ann Arbor to East Lansing to attend as guest of honor a ceremony for winners of the Wade H. McCree Jr. Awards, presented to journalists whose work promotes the advancement of justice. The awards were named after her husband—a federal judge, professor of law, and solicitor general of the United States dedicated to advancing greater understanding of the role of a free press in society. Mrs. McCree passed away recently, leaving behind her own legacy—one of helping others to attain their fullest potential.

Trained as a librarian at a time when few women had careers of their own, she led a full life and "enjoyed 90 wonderful years," said her son, Wayne County Circuit Court Judge Wade Harper McCree. Mrs. McCree not only graced the McCree Awards ceremony, held in conjunction with the Michigan Journalism Hall of Fame's annual induction ceremony, but also took time to talk to and encourage the winners and the important work they were doing. She had a genuine interest in other people and did a great deal to steer students toward public service careers and opportunities in the field of law.

She is survived by two children, four grandchildren, a brother, and two sisters. Memorial contributions may be made to the Friends School in Detroit, the Wade H. ## Plaques Marking Vincent Chin Case Installed in Ferndale

A State Bar plaque commemorating the Vincent Chin case and an accompanying marker, specially erected by the city of Ferndale through the efforts of former Mayor Craig Covey and other officials, were recently installed at the Nine Mile and Woodward crosswalk. In 2009, the State Bar of Michigan held a dedication ceremony, "From a Whisper to a Rallying Cry," to spotlight the Chin case as part of its Michigan Legal Milestones program focusing on significant cases and personalities in our state's legal history.

The June 1982 beating death of Vincent Chin in Highland Park and the lenient sentences meted out to his assailants caused an outcry in the Asian-American community and led to the birth of a civil and victims' rights movement. Chin had worked part-time in Ferndale at the Golden Star, a Chinese restaurant located where the Post Bar now stands. The plaques were installed just across the median from that site, which is also where the Asian-American community rallied and a Pan-Asian movement was born.
