In June, the Appellate Practice Section Council voted to recommend a rule change eliminating Michigan Court of Appeals docketing statements and approved its comment in favor of permitting reply briefs to responses to applications for leave to appeal in the circuit court and Court of Appeals. It was noted that MCR 7.203 had been amended (effective September 1, 2013) to clarify that an order assigning a case to a business court may not be appealed.

Public Act 2013-32 implements a 60day window after rejection by the state to "fix" problems with EDROs. Tremendous effort was expended by Robert Treat, Bill Kandler, Joe Cunningham, Rebecca Shiemke, and other members of the committee, for which the Family Law Section Council is most appreciative.
