SBM Hosts the "Future of Legal Services" Forum in Lansing

More than 50 prominent members of Michigan's legal community, including the chief justice of the Michigan Supreme Court, the president of the State Bar of Michigan, and the president of the American Bar Association, convened in Lansing on November 10 to discuss the future of legal services in Michigan. Other attendees included the directors of Michigan's attorney discipline agencies, the Michigan State Bar Foundation, and the Institute for Continuing Legal Education, as well as law school deans and past presidents of the ABA and the State Bar.

The "Future of Legal Services: Changes and Challenges in the Delivery of Legal Services" forum opened a new chapter in the work started by the State Bar of Michigan Judicial Crossroads Task Force. The task force's 2011 report contributed to a number of transformational and cost-saving changes now underway in Michigan's court system.



American Bar Association President William Hubbard spoke at the forum on "Our Justice System at an Inflection Point." Under Hubbard's leadership, the ABA formed a Commission on the Future of Legal Services to address how the legal profession can develop a new model to meet the needs of the underserved while enhancing the opportunities for lawyers to thrive in their practices. The commission's reporter is Prof. Renee Knake, co-director of Michigan State University College of Law's Kelley Institute of Ethics & the Legal Profession.


The symposium, co-hosted by the National Constitution Center and the Economic Club



Julian Bond Presents Damon J. Keith Biennial Lecture in Detroit

Activist Julian Bond presented Wayne State University Law School's sixth Damon J. Keith Biennial Lecture on October 23 at the school's Community Arts Auditorium in Detroit. Bond's presentation, "Under Color of Law," addressed the role the law has played in encouraging and thwarting the civil rights movement. Bond helped establish the Student Nonviolent Coordinating Committee and served as the first president of the Southern Poverty Law Center. He was chairman of the National Association for the Advancement of Colored People from 1998 to 2010.

Judge Matthew Sabaugh Honored by Macomb Homeless Coalition

The Macomb Homeless Coalition honored 37th District Court Judge Matthew Sabaugh November 20 in Sterling Heights. Judge Sabaugh initiated the Eviction Diversion Program, a voluntary program designed to help landlords and tenants resolve back-rent situations without credit-damaging court judgments in an effort to prevent homelessness.

Started in February 2014, the program is a collaboration of the 37th District Court, Michigan Department of Human Services, Macomb County Community Services Agency, Legal Aid and Defender Association, the Macomb Homeless Coalition, Mount Calvary Lutheran Church, and many other Macomb County charitable groups.
