"HABITAT FOR HUMANITY HOUSE BUILD"

in Honor of Detroit's Tricentennial

ne mile from Detroit's Tiger Stadium, on Roosevelt between Michigan Avenue and M.L. King Jr. Boulevard, stands an exceptional house. Exceptional not because of its size or design—it is 1,150 square feet with a full basement and three bedrooms—but because Michigan's real estate attorneys both raised the \$50,000 to sponsor its construction, and participated in the actual building process. Together with a number of Detroit metropolitan area law firms, banks, and businesses, the Real Property Law Section of the State Bar of Michigan sponsored this Habitat for Humanity "house build" as a special project to honor Detroit's Tricentennial (see sidebar).

Many section members, as well as their friends and families, worked on-site to build the house, which is in the Core City Neighborhood Development in southwest Detroit. They worked during the four designated build days on June 9, 16, 22, and 23 constructing the house floor, walls, and roof.

June 16th was designated for Miller, Canfield, Paddock and Stone's almost 30 volunteers "to wall" the house. Under the direction of section member Scot Norris, the group



worked efficiently to make a house appear on the floor built the previous Saturday, also under Norris's direction. Standard Federal Bank chose June 23rd to bring its approximately 40 volunteers to "roof" the house and participate in ground work for other nearby Habitat for Humanity house builds.

Before becoming the homeowner and taking on the responsibility of the monthly interest-free (20-year) mortgage payments,

the new homeowner must contribute "sweat equity" to qualify for the ownership of the house. Our selected homeowner, Mavis Street, worked with our volunteers at the worksite during several of our build days. She is the single mom of 11-year-old Stephanie and currently works as a clerk at the Detroit Medical Center.

The land was provided by the City of Detroit through the Michigan State Housing Development Authority. MSHDA and the Federal Home Loan Bank Board of Indianapolis each provided \$10,000 grants for the construction of the house.

Robert Dewaelsche, executive director of Habitat for Humanity Detroit, and Kenneth Benson, president and founder of Habitat for Humanity Michigan, joined section volunteers on the worksite June 9th and 16th. Benson was particularly pleased to participate in the raising of the walls, which were built through Michigan's Prison Build Program and delivered to the site by the Michigan National Guard.

The Prison Build Program's more than 100 minimum security inmates frame walls, build cabinets, and mill trim on prison grounds for houses built by HFH in Michigan. The inmates, who are at Michigan prisons in Ionia, Freeland, Lapeer, Plymouth, Kinross, and St. Louis, earn \$1.75 a day and learn valuable skills they can use upon their release. The Thumb Correctional Facility in Lapeer provided the walls for the section's house. The enthusiasm of the program participants and the

resulting job opportunities for them have provided positive evaluations of the Prison Build Program initiated by Benson. The program recently received national recognition as a finalist in the Council of State Governments' Innovations Awards Program.
