- Should a school be required to hire teachers who reflect the diversity in the American population, even if the most qualified teachers in the applicant pool are Caucasian males?
- Suppose that a male job candidate is slightly better qualified than a female candidate for a particular job. Should an employer be allowed to hire a lesser-qualified female candidate on the basis that the company has an under-representation of female employees?
- Should public schools in Michigan be allowed to refuse admission to the children of illegal immigrants?

Justice Markman gave a wonderful summary of the importance of our legal system founded upon separation of power, federalism, and power delegated by the people. All in attendance were reminded that such a government has been the exception, not the rule, and the respect for individual citizen rights was truly something worth never taking for granted.

My short remarks stressed the role of attorneys in protecting and safeguarding our freedom, while helping to ensure each individual can truly take advantage of the freedoms given us all.

It was a day to honor the students. It was a day to honor our system of rule of law. It was also a day to honor the people who make that system work, and at the core of such honor rests lawyers.

It is that system and those people who make our nation one that causes its citizens to be willing to risk or even give their lives in its defense.
