Effective January 1, expedited summary disposition docket in the court of appeals. Appeals of summary disposition orders will generally be briefed, argued, and disposed of within six months of filing. Highlights: 28 days to file appellant's brief; 21 days to file appellee's brief; 35-page limit for briefs. Cases can be removed from the expedited docket

Elder Law and Advocacy Section

The Section Council continues to closely monitor developments on Medicaid funded services for long-term care. This includes ongoing efforts to prevent the introduction of an "estate recovery" law. As of the date this column was prepared, no such legislation has been introduced. The section's annual fall conference was very successful, with over 100 participants and several nationally recognized speakers. Lisa Lepine of Macomb County was sworn in as the chairperson for 2004–2005.

International Law Section

The new federal tax law drastically reduces the marginal tax rate concerning foreign earnings reinvested in the United States.

This is accomplished by an 85 percent dividends received deduction for certain dividends received by a U.S. corporation from a controlled foreign corporation. In the case of a corporation earning income at the highest marginal federal tax rate (35 percent), the tax on qualifying reinvested foreign earnings would now be 5.25 percent. This reduction is for a limited time.

Labor & Employment Law Section

The Annual Mid-Winter Meeting will be held at the Ypsilanti Marriott, January 28–29. The featured speaker Friday night will be Jay Carney, Time Magazine's Deputy Washington Bureau Chief.
