PA 481 of 2004, effective October 1, 2005, amends the Estates and Protected Individuals Code by adding MCL 700.3705(6). Accordingly, not later than 28 days after a personal representative's appointment, he/she must give notice to the friend of the court for the county in which the estate is being administered, the names of the decedent's surviving spouse, and the individuals who are, for a testate estate, the devisees or, for an intestate estate, the heirs.
