Update on the Courts' Michigan Legal Help Website (sent by Laura Mancini):

More content continues to be added to the site. At the present time, the following subjects are represented:

Family Law

Domestic Violence and Protection from Abuse

Housing Law Consumer Law

Criminal Expungement

This includes 23 Toolkits, 52 Articles, 219 Common Questions with Answers, 7 automated interviews which populate 21 forms, information on 189 referral organizations and 342 courts in Michigan. Between August and December 2012, the website had 185,181 page views and 40,636 visitors. Since late November, the site has logged 3,600 visitors per week. There are four pilot centers operating:

Adams-Pratt Oakland County Law Library Allegan County Circuit Court Oscoda Public Library Wayne County Circuit Court

Training sessions on the Michigan Legal Help website will take place in 10 different locations throughout the state. Sessions will be one half-day in length. Several Committee members and advisors are volunteers for this effort.
