Hon. Melissa Pope has demonstrated great service to the bar, the public, and the Native American community in many ways throughout her career. Foremost among her many contributions is her work in the fight against domestic and sexual violence directed at indigenous women. She has used her dedication to the rule of law, commitment to tribal sovereignty and appreciation of the dignity of the individual to address this serious problem. She is well known throughout Indian Country for her efforts to raise awareness of this cancer and bring change and peace to the community.

Judge Pope is the Chief Trial Judge for the Nottawaseppi Huron Band of the Potawatomi, a position she has held since 2011. She has also served in the part-time position of Chief Justice of the Appellate Court for the Little River Band of Ottawa Indians since 2007. These two tribal communities are among the 12 federally recognized Indian Tribes in Michigan. Recognizing the importance of a collaboration between state and tribal courts, the Michigan Supreme Court created the Michigan Tribal State Federal Judicial Forum. The group consists of tribal judges from each of Michigan's federally recognized tribes, 10 state court judges, and federal judges and officials. Judge Pope currently serves as Co-Chair of the Forum.

The Michigan Domestic and Sexual Violence Prevention and Treatment Board is a seven-member body composed of a cross-section of professionals concerned with crimes of domestic and sexual violence. Members are appointed by the Governor, with the advice and consent of the Michigan Senate. The Board is assisted in carrying out its responsibilities by staff provided by the Michigan Department of Health and Human Services. Judge Pope currently serves as a member of this Board.

When the Michigan Supreme Court decided in April 2021 to amend Michigan Court Rule 8.128 to establish a 29 member Judicial Council to plan strategically for the Michigan judicial branch of government, the justices determined that the council would be representative of the state's diverse population and regions and advance diversity, equity, and inclusion. Judge Pope was selected to serve on the Judicial Council for an initial term ending December 31, 2022.

Her commitment to tribal sovereignty within the rule of law is best exemplified by an opinion that was ultimately reviewed by the United States Court of Appeals for the Sixth Circuit. In <u>Spurr v Pope</u>, 936 F.3d 478 (2019), the federal appellate court upheld her ruling that tribal courts have the inherent sovereignty to issue civil personal protection orders against even non-Indians who harass, stalk, or threaten tribal members within Indian Country.

Judge Pope is often called upon to address the issue of violence against indigenous woman at professional seminars and public gatherings. Her passion for the subject is obvious from a video of her short speech at the Quilt Walk For Justice in December 2015 at Washington, D.C. Melissa Pope has been a member of the State Bar of Michigan since 1999 and has been an active member of the American Indian Law Section throughout her legal career. She served several different terms as Section Chairperson and has actively participated in many SBM conferences and events.

While attending law school she served on the staff of a State Representative, and all of her positions after leaving that position have provided the foundation for her work on behalf of abused indigenous woman:

Since 2007, Judge Pope has served as an Adjunct Instructor on the faculty of the University of Detroit Mercy School of Law. She teaches American Indian Law one semester each year, and frequently also conducts a seminar course in the second semester.
