I met Jerry Schrotenboer in my second year of law school, in 2003. I'd been told by a professor that Jerry was requesting a student to help him with research for a case he was arguing before the Michigan Supreme Court. I knew that he'd won a case at the U.S. Supreme Court, and I was suitably nervous on the drive to the prosecutor's office. I knew—*knew*—that someone with his reputation had to be a high-powered, no-nonsense type. If I made any mistakes, my law career would be over before it began.

When he came out of his office to meet me, it wasn't with the brisk no-time-for-small-talk stride I'd expected. He walked out easily, nodded at me amiably and waved me back for me to follow him without saying anything. He had a relaxed manner and spoke casually, which helped to put me at ease. I quickly figured out that Jerry didn't need "help" with the case, he was just curious to see what a student at the new law school could do. I was fortunate to find some case law that bolstered the argument he would be making, and he was generous enough to let everyone concerned know that I'd been the one to come up with that particular point.

After that, I did some more work for him. That led to working in the district court in Jackson County as an intern. When I graduated, I stayed in touch with Jerry. He was an excellent mentor, and in fact, he hasn't stopped being one. Since graduating, I've called him with questions, and if it had anything to do with criminal appellate law, that was all the research I needed to do. If it was an area of law that wasn't within his realm of expertise, he could recommend someone who would be able to give me an answer.

To anyone who asked me if I've profited from knowing Jerry, I would answer that I continue to do so. I'm now living in Cincinnati, so that twelve years after graduating from law school, whenever he's in town to argue at the Sixth Circuit Court of Appeals and I'm able to leave work I still go to see him.
