Strategic Plan Implementation Plan & Budget

Mr. Berry asked Edward Pappas, Chair, Finance Committee to report on a two amendments to the budget, pertaining to the Insurance Risk Management and the Investment Consultant. Mr. Pappas called on Charles Toy to report on the recommendation from the Insurance Risk Management Subcommittee. Mr. Toy reported that the recommendations are to increase the D&O coverage, increase the umbrella policy coverage, and to increase the coverage's on the building and contents on the general liability and property policy.
