

Dear Ms. Sharlow:

I am writing to recommend Lynn Chard for this year's Michael Franck Award. Lynn is retiring in December after having worked at Michigan's Institute of Continuing Legal Education for (I believe) 34 years, the last 23 years as its director. In that capacity she took what was a slightly moribund CLE organization and transformed it into what is widely regarded as one of the best CLEs in the country. She grew ICLE in good times and in bad, providing top-quality courses, publications, and on-line resources for Michigan lawyers.

When Lynn started back in 1982, ICLE was a little shop housed on the fourth floor of Hutchins Hall in the U-M Law School. The Publications Department consisted of a small group of self-taught copy-editors sharing an office they affectionately called "The Pit." In 1983, Lynn became publications director. She immediately set to work to "change how things got done." She didn't have much publishing background, but she did have practice experience with an emphasis on research and writing, a library degree, and a great feel for business.

Lynn quickly went to work: (1) she set up a system for automatic renewals of print supplement subscriptions; (2) she understood the importance of updating materials and keeping them current; (3) she took control of research and writing by hiring ICLE's first legal editors; and (4) she identified the major topics that Michigan lawyers needed. During her tenure she added dozens of titles and topics to the book collection, and increased revenue by 600 percent.

Ten years later, in 1993, Lynn applied for the director's job. By chance I was a member of the search committee that hired her. My memo to the committee and the dean noted that although by then Lynn and I knew each other well:

[S]he insisted that I do a real interview. She was all business, and I must say that ... she was the most prepared and the most concrete [of the seven candidates]. I found her to be amazingly persuasive. She made two strong claims: (1) that she knows the CLE business as well as anyone out there; and (2) that she has earned the right to the job.

Lynn was the overwhelming choice of the ICLE staff. The executive committee recommended her, and never regretted it.

As director, Lynn was a juggernaut. Her business acumen is legendary. She grew ICLE to close to 50 employees, with an annual budget of \$6 million. On the publication side she did something I thought was impossible given the size of the staff: she made all of ICLE's books available on line, with all of them updated *nearly in real time*. Any book you access on ICLE's website is current within weeks (not months or years).

Lynn also was prescient about the role of the web in law and legal education. She made sure that ICLE was at the forefront of change, but safely so. Today no CLE agency in the U.S. has the on-line resources that ICLE has – books, seminars, list-serve communities, how-to kits, *etc.* – all available at reasonable prices, from your office, your laptop, your notebook, or your phone. Lynn insists on having a long-term plan for ICLE, which her team constantly revises.

ICLE is a joint venture of Michigan's law schools and the State Bar, but it is also a unit of the University of Michigan. Lynn thus has to serve many masters. She has done so with enthusiasm and aplomb. She is diplomatic, savvy, and direct, but she also has considerable backbone when it is required. Her executive committee meetings and materials are models of the form. Her budgets are conservative and nearly always on target.

Of course she cannot do all of these things alone. But Lynn has hired and promoted a great cadre of skilled people at ICLE. She creates an environment that makes her co-workers want to excel. Almost no one ever leaves, and people rave about working with and for Lynn. (I chaired one of her three-year review committees, and the comments from her staff were off the charts.) Lynn has also provided opportunities for women to move into upper management. At ICLE, most of the senior staff positions have been occupied by women over the years.

Lynn has formed lasting relationships with contributors, cosponsors, other CLEs, and the State Bar and its sections, and community leaders. She brought out a great motto: "Your Partner in Practice." During her tenure, ICLE has garnered more than 40 awards from the Association of Continuing Legal Education (ACLEA), in every category: courses, publications, marketing, and technology.

Lynn is the Steve Jobs of CLE (without the difficult personality). She took ordinary products and made them fun, and authoritative, and easy to work with, and instantly accessible. In short, she made ICLE indispensable – every Michigan lawyer who can afford to be an ICLE Partner signs up, and most renew religiously every year. I think Mike Franck would have been delighted to honor Lynn Chard with the award named for him.

When I heard that the Institute of Continuing Legal Education intended to nominate Lynn Chard for the distinguished Michael Franck Award, I jumped at the opportunity to add my thoughts – and praise – to the many others that I am sure you will receive from Lynn's colleagues around the country.

As Executive Director of Massachusetts Continuing Legal Education (MCLE) since 1980, my tenure has overlapped in its entirety with Lynn's. Over these many years, I have come to know Lynn very well, and cherish her both as a CLE colleague and good friend. I am sure that you are aware of what she means to ICLE and the education of lawyers in Michigan, but you may not be as familiar with her contributions to the world of CLE beyond your state's borders and her influence on those of us around the country who have been fortunate to work with her.

Under Lynn's leadership, ICLE has become arguably the best CLE operation in the nation, and certainly a model organization, to which all others (including mine) repeatedly look for guidance. She's been a trailblazer and a visionary, always willing to push the envelope and take risks to improve the way lawyers (whom she refers to as her partners) learn and develop professionally. As the times changed, she stayed on the cutting edge so as to change and adapt with them. As lawyers shifted learning preferences, she shifted too to respond in kind. As technology began to revolutionize the way people learn and to challenge those of us who have been at this business for a long time, she did not shy away, but instead embraced it as yet another way to accomplish our educational mission. She was among the first of our number to see the benefits and innovative uses of the continuing advances in technology in delivering information and education.

She is a passionate learner, reading about and taking courses on how to be a better leader and manager, how to improve the efficiency of her organization and those who work there, and how to better teach others. And she is always very willing to share that knowledge with others. As a result of that same passion and forward-thinking mindset, she naturally became a leader in the CLE world.

Lynn has been the go-to person for many of us in our business. Always willing to lend an ear and a helping hand, she has been instrumental in my own career and, in many ways, MCLE's success and prominence. I sought Lynn's strategic and learned advice on many occasions and often find

myself wondering what Lynn would do (or, likely, already did) if confronted with the same issue. For example, as we expanded our publishing program throughout the 1990s, I called on Lynn for her advice. I worked with Lynn for over 30 years at the Institute of Continuing Legal Education. The length and variety of my experience gives me a unique perspective on her contributions.

I remember vividly when Lynn was hired in 1980 as Publications Director at ICLE. Her background included a degree in library science as well as one in law, and several years at the State Appellate Defender Office as an attorney. At the time, ICLE was a small outfit located on the fourth floor of the Michigan Law School. On the publications side, we published a limited number of books of varying degrees of interest to practicing lawyers. Some were treatises, a few were practical, and a number were on arcane or federal topics. They were updated when their authors could find time to do so.

When she was hired, Lynn "hit the ground running." Her strong guiding principles were to find out what **practicing lawyers** needed, and then apply the best business principles to meet those needs. She talked to customers and found out what they needed to help them practice law. She identified successful Michigan practitioners who were willing to share their expertise with fellow lawyers. She hired legal editors to do regular updating. Over time, our book collection grew to over 60 titles that met the needs of Michigan lawyers for practical "how to" guidance and reliable, current information.

Those two principles – customer needs assessment and business acumen – guided Lynn's work at ICLE. In 1993, she became Director and her focus broadened. This was a time of major technological changes. Lynn quickly realized the impact of those changes -- and the Internet in particular -- on publishing and businesses. ICLE developed what was probably the first web site for lawyers in the state of Michigan. We collaborated with the State Bar of Michigan to develop a free database of Michigan caselaw (Michigan Law Online), of great benefit to Bar members. We put books and courses online, developed continual updating, and launched the ICLE Partnership.

Lynn has also been a force for developing educational resources of great value to Bar members. Under her guidance, ICLE worked with the Probate and Estate Planning Section to develop the Probate and Estate Planning Certificate Program, followed by a similar program with the Family Law Section. Lynn worked in public service at SADO for many years, and I know that she didn't treat it like a 40 hour job, working long hours to make sure quality representation was provided through the appellate processes.

Since SADO she has worked for more than 25 years at ICLE. She guided that organization from a "paper and pencil" support service through the daunting technological changes of the past 20 years. When I started practice as a family law attorney there was little in the way of "help" for a young attorney trying to understand the landscape of the law. Indeed, it would be no exaggeration to say that Family Law was, essentially, the Moon, a seat of the pants and airless arena of practice. In 1995 this wasn't obvious to the mainstream of lawyers or courts. In the Family Law arena in particular, Lynn and ICLE have seen that technologies of all sorts (old fashioned publishing, lectures, software) could be used to help younger and more established lawyers to represent their clients in more efficient and qualitative ways. My guess is, prior to Lynn, ICLE, like most such organizations, would only have been looking in the rear view mirror. Lynn has been able to see the directions in our culture and has helped to create an organization that is ahead of the curve in its thinking, in its support of our profession.

She would be an excellent choice for this award.
