The Board received written reports from Justice Initiatives and Governmental Consulting Services.

Court Proposals

1. ADM File No. 2010-25 - Proposed Amendment of Rule 7.210 of the Michigan Court Rules

The proposed amendment would require trial courts to become the depository for exhibits offered in evidence (whether those exhibits are admitted or not), instead of requiring parties to submit exhibits offered in evidence when a case is submitted to the Court of Appeals on a claim of appeal.

The Civil Procedure & Courts Committee and the Criminal Jurisprudence & Practice Committee recommended opposition. The Appellate Practice Section and the Criminal Law Section recommended support.

A motion was offered and supported to support the proposed amendment. A roll call vote was taken: 14 ayes, 12 nays and one abstention. Motion approved.

Legislation

Juvenile Competency

<u>SB 0246</u> (Schuitmaker) Juveniles; criminal procedure; juvenile competency standards; revise. Amends sec. 1, ch. XIIA of 1939 PA 288 (MCL 712A.1) & adds secs. 18n, 18o, 18p, 18q, 18r & 18s to ch. XIIA.

<u>SB 0247</u> (Schuitmaker) Juveniles; criminal procedure; juvenile competency and culpability; clarify. Amends secs. 498d, 498e & 498h of 1974 PA 258 (MCL 330.1498d et seq.) & adds secs. 1060, 1060a, 1060b, 1060c, 1062, 1064, 1066, 1068, 1070, 1072 & 1074.

<u>HB 4555</u> (Lipton) Juveniles; criminal procedure; juvenile competency and culpability; clarify. Amends secs. 498d & 498h of <u>1974 PA 258</u> (MCL <u>330.1498d</u> et seq.) & adds secs. 1060, 1060a, 1060b, 1060c, 1062, 1064, 1066, 1068, 1070, 1072 & 1074.

HB 4556 (Lipton) Juveniles; criminal procedure; juvenile competency standards; revise. Amends sec. 1, ch. XIIA of 1939 PA 288 (MCL 712A.1) & adds secs. 18n, 18p, 18o, 18q, 18r & 18s to ch. XIIA.

A motion was offered and supported to support this bill package, provided the amendments advocated by the Criminal Law Section regarding a qualified person performing a competency exam are adopted. Motion approved.

SB 0464 (Schuitmaker) Criminal procedure; other; development of investigative protocols and abuse and neglect interview protocols for vulnerable adults; require by certain local agencies. Amends sec. 11b of <u>1939 PA 280</u> (MCL <u>400.11b</u>).

The Board agreed to take no position on this bill based on a Keller analysis.

SB 0688 (Schuitmaker) Crimes; perjury; unsworn declaration made under penalty of perjury; include as a statement punishable as perjury. Amends sec. 423 of 1931 PA 328 (MCL 750.423). The Civil Procedure & Courts Committee recommended amendment to the bill. The Justice Policy Initiative

recommended support.

SB 0689 (Schuitmaker) Civil procedure; evidence; uniform unsworn foreign declarations act; create. Amends sec. 2102 of 1961 PA 236 (MCL 600.2102) & adds ch. 21A.

The Civil Procedure & Courts Committee recommended an amendment to the bill. Elizabeth Lyon noted that amendments were already being incorporated into substitute drafts of the bills.

A motion was offered and supported to support the bills. Motion approved.

SB 0707 (Schuitmaker) Civil procedure; discovery; uniform interstate depositions and discovery act; adopt. Amends sec. 1852 of 1961 PA 236 (MCL 600.1852) & adds ch. 22.

A motion was offered and supported to support the bill. Motion approved.

SB 0743 (Jones) Children; abduction; uniform child abduction prevention act; create. Creates new act. The Domestic Violence Committee recommended opposition.

Action on this bill was deferred.

Court Rules

ADM File No. 2005-11 – Proposed Alternative Amendments of the Code of Judicial Conduct Two alternative proposals are published for comment. Alternative A combines Canon 4 and Canon 5 so that

the obligations imposed with regard to extrajudicial activities are the same for both law-related and non lawrelated functions. Alternative B is modeled loosely on the ABA Model Code of Judicial Conduct. The most recent iteration of the ABA Model Code splits the existing language of Michigan's Canon 4 through Canon 6 into 15 separate rules. For purposes of the proposed language of Alternative B, however, the separate model rules are combined in the proposed revised text of Michigan's current two Canons, and would retain nearly all the language that currently exists in Canon 4 and Canon 5. But the proposal is similar to the ABA Model Code in that proposed Canon 4 would begin with a description of the underlying foundational requirements for any extrajudicial activities (i.e., participation in the activity must not undermine the judge's independence, integrity, or impartiality) and other general requirements, and then would set out the allowed fundraising and other financial activities in Canon 5.

Either proposal would eliminate the language of Canon 7 that prohibits a judge from accepting a testimonial, and would clarify Canon 2 so that activities allowed under Canon 4 and Canon 5 would not be considered a violation of the principle of use of the prestige of office. Both proposals contain proposed language that is intended to clarify the scope of activities in which a judge may participate, especially if those activities also serve a fundraising purpose. In Alternative A, this language is included at Canon 4D; in Alternative B, this language is included at Canon 5A (3).

The Criminal Jurisprudence & Practice Committee recommended support and amendment. The Judicial Ethics Committee recommended amendment.

Action on this proposed court rule amendment will be deferred for action by the Executive Committee in anticipation of forthcoming recommendations from Sections and Committees.

ADM File No. 2010-26 - Proposed Amendment of Rule 7.210 and Rule 7.212 of the Michigan Court Rules

The proposed amendments of MCR 7.210 and MCR 7.212 would extend the time period in which parties may request that a court settle a record for which a transcript is not available and would clarify the procedure for doing so.

Action on this proposed court rule amendment will be deferred for action by the Executive Committee in anticipation of forthcoming recommendations from Sections and Committees.
