Court Rules Proposals

Old Business

ADM File No. 2012-30 - Proposed Amendments of Rule 2.621 and Rule 2.622 of the Michigan Court Rules

The proposed amendments of MCR 2.621 and MCR 2.622 were submitted to the Michigan Supreme Court on behalf of the "Receivership Committee" (a committee created because of a need identified by the Debtor/Creditor Rights Committee of the Business Law Section of the State Bar of Michigan) to expand and update the rules regarding receivership proceedings.

The committee recommends that no reconsideration be taken on this amendment.

New Business

ADM File No. 2012-23 - Proposed Amendment of Rule 8.109 of the Michigan Court Rules The proposed amendment of MCR 8.109 would provide explicit authority for courts to use audio and video recording equipment to make a record of court proceedings and that trial courts using recording equipment would be required to follow the standards relevant to recording of proceedings that are published by the State Court Administrative Office.

A motion was offered and seconded to support this amendment. The motion passed.

ADM File No. 2012-26 - Proposed Amendment of Rule 8.111 of the Michigan Court Rules This proposal would clarify that the reassignment requirement applies regardless whether the court is acting in the capacity of a trial court or as an appellate court, such as a circuit court considering an appeal of a district court or probate court determination.

A motion was offered and seconded to support this amendment. The motion passed.

ADM File No. 2013-10 - Proposed Amendments of Rules 2.107 and 2.117 of the Michigan Court Rules

The proposed amendment of MCR 2.107 would provide clarification by adding the term "order" so that after either a final judgment or order has entered, papers should be served on the party after the time for appeal has passed. The proposed amendment of MCR 2.117 would clarify that when an attorney appears in an action by filing or defending a post judgment motion, the duration of the attorney's appearance would be the same as that of an attorney filing or defending the original pleadings.

A motion was offered and seconded to support this amendment. The motion passed.

Legislation

HB 4933 (Heise) Occupations; attorneys; eligibility criteria for foreign attorney admission to the bar without examination; modify residency requirement. Amends sec. 946 of 1961 PA 236 (MCL 600.946).

A motion was offered and seconded to support this legislation. The motion passed.

H.R. 2509 and S. 1224: Civil Justice Tax Fairness Act of 2013

These two identical bills amend the Internal Revenue Code to allow: (1) an exclusion from gross income for amounts received (whether by judgment or settlement, as lump sums or periodic payments) on account of a claim of unlawful discrimination; (2) income averaging for back pay and front pay amounts received from such claims; and (3) an exemption from the alternative minimum tax (AMT) for any tax benefit resulting from the income averaging of amounts received from an unlawful discrimination claim.

These items were tabled until the November meeting.

LEADERSHIP REPORTS

President's Report, Bruce A. Courtade, President

Mr. Courtade reported that the scheduled meeting with the Officers of the Board of Commissioners and the Supreme Court was cancelled due to a press conference where the Supreme Court rolled out the new rules regarding expanded use of interpreters in Michigan Courtrooms.

Mr. Courtade congratulated Commissioner Charles Hegarty on his appointment to the Wayne County Circuit Bench.

Mr. Courtade informed the Board that the Bar submitted to the Secretary of State a letter asking Secretary of State Johnson to revisit the issue of whether donations to issue ad campaigns basically in judicial elections should be revisited and whether those donations should face mandatory disclosure. He said that this was discussed at the July 16 Executive Committee conference call and discussed before this board on July 26. This action was taken in furtherance of a unanimous vote of the RA which adopted a policy position in favor of full disclosure in judicial campaigns. That vote was taken in September 2010. It was also consistent with the recommendations of the Campaign Finance workgroup that was appointed in the wake of the Oakland County Circuit Court elections. The workgroup came back and encouraged the Board and the staff to place emphasis on this issue and to make it a priority. It received a little bit of coverage. There is a posting on the SOS website and open for public comment.

Executive Director's Report, Janet K. Welch, Executive Director

Indigent Criminal Defense Update

Ms. Welch reported that the names of Ms. Nancy Diehl, Ms. Brandy Robinson and Mr. Dennis Clark were submitted by the State Bar to the Governor's office for consideration for his appointment to the Indigent Criminal Defense Commission. The Governor will select one of the names for appointment.

Free Section Membership

Ms. Welch explained the proposal for automatic free membership.

A motion offered and seconded to approve the proposal to rescind automatic free memberships. The motion passed.

The three have responded jointly informing Mr. Vauter that they appreciated his input and that ongoing dialogue with the Elder Law, Probate and Family Law sections is taking place.

Ms. Welch informed the Board of two resolutions recognizing Michigan Patriot Week.

Ms. Welch reported that there as a result of torrential rain in the Lansing area last week, the Garden Level of the State Bar was flooded. Ms. Welch indicated that the employees were relocated to the PMRC Education Center while repairs were taking place.
