RE: Status of Family Division Court Hearings, Effective 4/13/2020

Effective the week of April 13th, assuming the Governor will extend the "Stay at Home" Executive Order requiring the Courts to remain closed, we are prepared to have all Circuit & Family Court staff working remotely and all Judges and Referees conducting the majority of hearings remotely via Zoom virtual courtrooms. Please see below for the list of Family Division hearings and appointments that will be conducted during this time. Staff will be sending out Zoom notices for each hearing and appointment that provides detailed instructions for how attorneys and parties participate. Please find attached a sample Zoom notice. Attorneys/parties also have the option to call in, if they do not have access to a computer. The virtual hearing is a court proceeding, and therefore, an extension of the courtroom, so appropriate conduct and attire is expected and required. During virtual hearings or appointments, please remember to speak one at a time and to pause prior to speaking in case there is any audio/video lag. Please mute yourself when not speaking in order to avoid any potential background noise.

It is the responsibility of attorneys to communicate with their clients prior to the hearings. If this is not possible, the Zoom virtual courtrooms do have private breakout rooms that you can be put in to talk with your client. You will be given a timeframe for how long you have to talk with your client. Please try to be finished by the time you reenter the Zoom hearing or appointment. Attorneys are encouraged to provide the courts with your email address on any correspondence you submit, and to accept service via email, rather than mail, during this crisis.
