RE: Status of Phase II Court Proceedings, Effective 10/28/2020

Due to the increase in local COVID-19 cases, the Muskegon County Courts are required to return to Phase II of their return to full capacity plan. Please see below for the list of hearings and appointments that will be conducted remotely versus in-person during this time.

- Staff will be sending out Zoom notices for each hearing and appointment that provides detailed instructions for how attorneys and parties participate. Attorneys/parties also have the option to call in, if they do not have access to a computer.
- The virtual hearing is a court proceeding, and therefore, an extension of the courtroom, so appropriate conduct and attire is expected and required. During virtual hearings or appointments, please remember to speak one at a time and to pause prior to speaking in case there is any audio/video lag. Please mute yourself when not speaking in order to avoid any potential background noises.
- It is the responsibility of attorneys to communicate with their clients prior to the hearings.
- Attorneys are encouraged to provide the courts with your email address on any correspondence you submit, and to accept service via email, rather than mail, during this crisis.
- Dockets will continue to be displayed on the court's website and copies of hearings can be made by email request to the assigned Judge's Judicial Secretary.

*Case-by-Case Basis- More complicated court proceedings will be subject to the assigned Judge's capacity to conduct such proceeding remotely. That capacity is to be evaluated on a case-by-case basis.

District Court

All proceedings scheduled to take place in-person on Wednesday October 28th and Thursday October 29th will be conducted in-person as previously scheduled. All district court hearings scheduled to take place in-person between Monday, November 2nd and Thursday, November 5th (with the exception of Landlord/Tenant summary proceedings and Preliminary Examinations) will be adjourned, rescheduled and re-noticed for a later date, primarily to be conducted via Zoom Conferencing Technology.
