Message from Susan Murphy:
The meeting held on September 17,
2009 resulted in unanimous votes
opposing the proposals outlined below.
1) Should the Assembly support an

This was very interesting — especially
since we can all practice in front of any
Court in this State. Unanimously
opposed.

2) Should the Court Rules be amended to require all plea-based discussion to be held on the record? The language was overbroad and it was unanimously opposed.

3) The Family Law Division requested the adoption of a rule which would control attorney solicitation before service of process. This request was withdrawn. The Family Law Division will revisit the issue and bring it back at the Assembly's March 2010 Meeting.

With regard to other matters, did you know that as a State Bar Member you can access free legal research from the State Bar website? Just use your log-in and password, enter the member page and access "Casemaker." This is new and some Shepardizing is still recommended, but it could supplement your current researching methods. Jackson County Probate Court Filing Fees and Procedures

New Probate Court Procedures

If you file documents and want copies returned by mail please enclose or provide the Probate Court with a self addressed stamped envelope. Otherwise any duplicates provided for true copy will be placed in our box for someone to come and pick up. If you wish to receive a phone call when it is ready for pick up please indicate that when filing the documents.

When filing paperwork by mail, we will only true stamp one copy. If you wish for more than one true copy you may bring your own copies to the window to stamp for free or we will true any additional copies provided for \$.25 per page.

When filing an informal estate, please be aware that it may take upwards of 1 week before it is ready; it all depends on our staffing situation at the time of filing. If we are unable to immediately review your paperwork, we will call you when it is ready.

The Probate Court will no longer provide the Legal News with the Notice to Creditors or any other document for publication in any newspaper. It is the responsibility of the Attorney to provide a copy of the document for publication to the newspaper and to ensure any required Affidavits of Publication are filed with the Probate Court.

The Probate Court now requires specific language for the orders and letters on minor conservatorships. Please obtain a copy of the language and new requirements at the time of filing the minor conservatorship paperwork.

If you are filing paperwork for separate but related files, we need a copy for each file. You can put multiple case numbers/names on the same document but you must still provide a copy for each file. For example a Guardianship file and Conservator file for the same ward can share a proof of service but we still need two copies of the proof of service, one for each file.

Leaving paperwork at the window without acknowledgement from the staff is done at your own risk.

Please let the Probate staff know at the time of filing that you are filing paperwork for a case that is set for hearing within the next five days. Failure to inform the staff may result in your paperwork not getting into the file in time for the hearing, as the files are sent up a few days in advance of the hearing.

If you call ahead for a file number and hearing date you are required to file your paperwork within 7 days. Recently there has been an influx of hearing dates given over the phone and a failure by the law offices to file the paperwork in time, if at all. This has an impact on both the GALs and DHS since they are not appointed until the paperwork is filed with the Probate Court.

PROCESS FOR CASE EVALUATOR APPLICATION (REOPENING PERIOD) FOR CIRCUIT/DISTRICT/PROBATE COURT CASE EVALUATOR POOL COVERING JULY 1, 2010 THROUGH JUNE 30, 2014

In accordance with MCR 2.404 and Local Administrative Order 2003-1, applications are now being accepted from individuals applying for service as a Circuit/District/Probate Court Case Evaluator. To apply complete SCAO Form MC34/Case Evaluator Application and submit it to the ADR Clerk, Marion R. Stone, 312 South Jackson Street, Jackson, MI 49201, no later than December 1, 2009. Forms may be obtained at www.courts.michigan.gov/scao/courtforms/index.htm.

Eligibility requirements include:

- A. The applicant has been a practicing lawyer for at least five years and is a member in good standing of the State Bar of Michigan.
- B. The applicant resides, maintains an office, or has an <u>active</u> practice in the County of Jackson;
- C. The applicant must demonstrate that a substantial portion of the applicant's practice for the last five years has been devoted to civil litigation matters, including investigation, discovery, motion practice, mediation, settlement, trial preparation, and/or trial.

Applications will be reviewed by the Case Evaluator Selection Committee in early January 2010 and parties will be notified by February 1, 2010, of their acceptance or rejection to the case evaluator pool. Appeals of rejection must be made by February 15, 2009, in writing and submitted to the ADR Clerk. The Chief Circuit Judge will review all appeals and make a decision by March 15, 2010. The new Case Evaluator List will be issued April 1, 2010 to commence use on July 1, 2010. For further details please refer to MCR 2.404 and LAO 2003-1.


