New SCAO Forms for Family Law

SCAO has updated several of its family law forms, including the Uniform Spousal Support Order (FOC10b), Uniform Spousal Support Order No Friend of the Court Services (FOC10c), Uniform Child Support Order (FOC10), and Uniform Child Support Order No Friend of the Court Services (FOC10a). None of these forms can be used after December 31, 2010, but the old versions of the Uniform Child Support Orders can be used with handwritten corrections until December 31.

Representative Assembly News

From Susan Murphy:

The Unsung Hero Award was awarded posthumously to Kevin J. Moody of Lansing, and the Michael J. Franck Award was given to 2 recipients – John F. Van Bolt, Executive Director & General Counsel, State of Michigan

Attorney Discipline Board, and Sheldon J. Stark, Director of Specialty Programs, ICLE.

Master Lawyers Section – This new section is for attorneys age 60 and over or attorneys with 30+ years of service. Members of this new section will be mentoring younger lawyers and helping fellow lawyers wind down business activities. The objective is for senior lawyers to continue the professional responsibilities to the profession post retirement.

New Standing Committee for Representative Assembly – A request to create a new standing committee -Past Chairperson's Committee - was referred to Rules & Calendar for review at the April meeting. The goal is for the Rules & Calendar committee to determine what bylaws might need to be amended and what would be the purpose of this standing committee. Revised Uniform Arbitration Act – Ongoing discussions continue as to whether the Representative Assembly should support or oppose the adoption of the Revised Uniform Arbitration Act. The Special Issues Committee was not ready to present its findings or recommendations so the matter was tabled to April 2011.

Uniform Collateral Consequence of Conviction Act – The Representative Assembly was considering whether to support or oppose the adoption of the Uniform Collateral Consequences of Conviction Act. In summary, this Act ensures timely notification of other civil consequences of criminal convictions – such as deportation, prohibition for

certain employment or licensing, and restriction to federal-subsidized housing. This matter was referred to the Special Issues Committee for further consideration.

The Act does not create a duty on defense counsel or elevate claims of ineffective assistance of counsel, nor does it justify setting aside pleas if notice is inadequate.

Equal Access to Identification Documentation – This issue was raised due to the fact that some individuals who have lawful presence in the State of Michigan are not able to obtain State Identification because of the Secretary of State's interpretation of what documents it must accept to grant State Identification. After much debate over how the motion should be worded to ensure we were asking the Secretary of State to perform rule-making procedures rather than a directive of what document should be accepted, this matter was referred to the drafting committee.

Prior Disclosure of Source of Funding for All Expenditure for Electioneering Communications – This issue was presented to support an amendment to the Michigan Campaign Finance Act regarding disclosure prior to a judicial election of the sources of funding for

all expenditures for electioneering communications consistent with the recent U.S. Supreme Court cases of Caperton v Massey Coal Company and Citizens United v Federal Elections Commission. The Resolution passed.

NOTICE TO THE BAR ASSOCIATION:

PROCESS FOR CASE EVALUATOR APPLICATION (REOPENING PERIOD) FOR CIRCUIT/DISTRICT/PROBATE COURT CASE EVALUATOR POOL COVERING JULY 1, 2011 THROUGH JUNE 30, 2015

In accordance with MCR 2.404 and Local Administrative Order 2003-1, applications are now being accepted from individuals applying for service as a Circuit/District/Probate Court Case Evaluator. To apply complete SCAO Form MC34/Case Evaluator Application and submit it to the ADR Clerk, Marion R. Stone, 312 South Jackson Street, Jackson, MI 49201 no later than December 1, 2010. Forms may also be obtained from the ADR Clerk's Office or at www.courts.michigan.gov/scao/courtforms/index.htm.

Eligibility requirements include:

- A. The applicant has been a practicing lawyer for at least five years and is a member in good standing of the State Bar of Michigan.
- B. The applicant resides, maintains an office, or has an <u>active</u> practice in the County of Jackson;
- C. The applicant must demonstrate that a substantial portion of the applicant's practice for the last five years has been devoted to civil litigation matters, including investigation, discovery, motion practice, mediation, settlement, trial preparation, and/or trial.

Applications will be reviewed by the Case Evaluator Selection Committee in early January 2011 and parties will be notified by February 1, 2011, of their acceptance or rejection to the case evaluator pool. Appeals of rejection must be made by February 15, 2011, in writing and submitted to the ADR Clerk. The Chief Circuit Judge will review all appeals and make a decision by March 15, 2011. The New Case Evaluator List will be issued April 1, 2011 to commence use on July 1, 2007. For further details please refer to MCR 2,404 and LAO 2003-1.
