## Smedley elected to 14th Circuit bench

#### Voters choose woman in close race

Besting a field of six colleagues through primary and general elections, Annette Smedley was elected to the 14th Circuit bench. She will be sworn in at 3:30 p.m. Friday 28 December in the courtroom of James M. Graves Jr., sixth floor of the Kobza Hall of Justice.

Only 252 votes separated Judge-Elect Smedley from Raymond Kostrzewa. In a very narrow race, Muskegon County voters gave Ms. Smedley 28,494 votes and Mr. Kostrzewa 28,242.

The 2012 election was the first time since 1968 for an open circuit judgeship. That year the Legislature created a third seat on the 14th bench. Charles A. Larnard Jr. beat Jared Collinge for the post.

Ms. Smedley succeeds Hon. James M. Graves Jr., the longestserving jurist in county history. Attaining age 70, Judge Graves is



age-limited and unable to seek reelection. The term is for six years and pays \$139,919 annually.

The 7 November decision by voters ended almost a year's effort by six attornevs who filed for election.

kids' birthdays, outings, and extra events throughout the year.


