Thanks to Joseph Bader, Chief Trial Attorney of the Muskegon County Prosecutor's Office, we have a view into the profession as preserved on the MCBA's photo roster from 35 years ago. Men boasted sideburns. The only woman member, R. Aloise Gillard, relied on the trendy bouffant hairstyle.

Mr. Bader located the abandoned composite photo and preserved it. We're in discussion now with John McGarry, director of the Muskegon County Museum, to determine if that institution not only might store the artifact, but also consider creating a display on the history of courts, law, and lawyers in Muskegon County over the decades.

"It's important to preserve the entire history of Muskegon County and certainly the law profession is an important part of that," Mr. McGarry said.
