



## APPROVED FINANCIAL INSTITUTIONS

Rule 1.15A of the Michigan Rules of Professional Conduct, also known as the Trust Account Overdraft Notification (“TAON”) rule, requires that lawyer trust accounts be maintained in financial institutions approved by the State Bar of Michigan. Rule 1.15A also requires the State Bar of Michigan to publish the list of approved financial institutions. The financial institutions listed below have obtained State Bar of Michigan “approved status” to serve as a depository for lawyer trust accounts in accordance with the TAON rule.
