[HB 4353](#) (Santana) Animals; animal shelters; animal shelters to deny adoptions under certain circumstances; require, and allow animal shelters to consider prior criminal history before adoption. Amends sec. 1 of [1969 PA 287](#) (MCL [287.331](#)) & adds sec. 8c.

[HB 4355](#) (Muxlow) Animals; animal shelters; ICHAT search by animal control shelters and animal protection shelters when allowing an animal adoption; require. Amends [1969 PA 287](#) (MCL [287.331](#) - [287.340](#)) by adding sec. 8b.

[SB 0219](#) (Jones) Crimes; animals; ownership of animals by a person convicted by certain crimes against animals; require court to prohibit for a period of at least 5 years. Amends secs. 49, 50, 50b & 158 of [1931 PA 328](#) (MCL [750.49](#) et seq.).

[SB 0220](#) (Bieda) Law enforcement; reports; access by animal shelter to certain criminal history record information through ICHAT; allow without a fee for purposes of animal adoption. Amends sec. 3 of [1935 PA 120](#) (MCL [28.273](#)).

Explanation of the position, including any recommended amendments:

The four bills generally do the following:

HB 4353: Animal rescue shelters and animal control shelters cannot adopt to those who have been convicted of an animal abuse offense (defined) within 5 years (and may refuse to adopt to those who were charged with such an offense but plead to another offense); this is the "Animal Adoption Protection Act."

HB 4355: establishes the requirement that shelters check the existing iCHAT system before adopting an animal to make sure the potential adopter is not listed as having committed an animal abuse offense.

SB 219: amends the animal cruelty statute to strengthen sentencing provision, regarding ban on ownership of animals.

SB 220: amends the statute on fingerprint records to waive the fee for animal shelters to check iCHAT in connection with adoptions; it also requires the State Police to compile a record of all animal abuse offenses and include them in its criminal history record database.

As was the case with the previous versions of this legislation introduced in the 2013-14 legislative session, the Council supports these bills as providing an appropriate and reasonable measure to protect animals as well as humans, given the established connection between animal abuse and other violent behavior. It strikes a balance by making the information available only to parties with a need to know. The iCHAT system is more cost effective, efficient, and comprehensive than the registry initially proposed. The Council continues to recommend expanding those entities required to search the database to breeders and others who sell, as well as adopt, animals.
