#### **Bill Number:**

<u>SB 0841</u> (Jones) Crimes; penalties; penalties for certain violations involving food assistance; revise, and provide for forfeiture of property obtained in the violation. Amends sec. 300a of <u>1931 PA 328</u> (MCL <u>750.300a</u>).

<u>SB 0842</u> (Jones) Criminal procedure; sentencing guidelines; sentencing guidelines for crime of food stamp fraud; revise to reflect increased penalties. Amends sec. 16o, ch. XVII of <u>1927 PA 175</u> (MCL <u>777.16o</u>).

<u>SB 0843</u> (Jones) Human services; other; inspector general within the department of human services to appoint agents with limited arrest powers and the powers conferred on peace officers; allow. Amends sec. 43b of <u>1939 PA</u> <u>280</u> (MCL <u>400.43b</u>).

<u>SB 0844</u> (Jones) Weapons; other; certain agents of the state department of human services office of inspector general; exempt from certain weapons prohibitions. Amends sec. 231 of <u>1931 PA 328</u> (MCL <u>750.231</u>).
