HB 5658 would amend the "Revised judicature act of 1961" (MCL 600.2950) to include animals in personal protection orders. Twenty-nine states, plus the District of Columbia and Puerto Rico, have enacted laws that allow pets to be included in domestic violence protection orders. (https://www.animallaw.info/article/domestic-violence-and-pets-list-states-include-pets-protection-orders) "Researchers have found that between 71% and 83% of women entering domestic violence shelters reported that their partners also abused or killed the family pet. And another study found that in families under supervision for physical abuse of their children, pet abuse was concurrent in 88% of the families." (http://www.humanesociety.org/issues/abuse_neglect/qa/cruelty_violence_connection_faq.html). Many domestic violence victims are reluctant to leave an abusive situation for fear of what will happen to their animals.
