HB 4741 (Bieda) Family law; personal protection orders; prohibition against harming animals owned by petitioner; include in personal protection order. Amends sec. 2950 of <u>1961 PA 236</u> (MCL <u>600.2950</u>).

HB 4742 (Bieda) Crimes; domestic violence; penalties for killing or torturing animal in perpetration of domestic violence; increase. Amends sec. 50b of <u>1931 PA 328</u> (MCL <u>750.50b</u>).

Letter in Support of House Bills 4741 and 4742

Dear Representative Bieda,

The Animal Law Section of the State Bar of Michigan ("ALS") is a Section made up of attorneys who choose to voluntarily join. ALS was formed to monitor legal issues associated with animals and their owners or custodians. Our purpose includes advocacy of responsible, humane, and ethical treatment and care of animals. We provide education, information and analysis about issues of concern through meetings, seminars, the web, public service programs, and publication of a newsletter.

As you are aware, HB 4741 and 4742 will amend MCL 600.2950 and 750.50b, respectively, regarding the inhumane treatment of a pet in the course of or as a means of perpetrating an act of domestic violence. HB 4741 regards the issuance of a personal protection order. It affords protection to victims from acts of animal cruelty perpetrated against an animal in which the petitioner victim has an ownership interest. HB 4742 increases the statutory penalty for those persons who commit acts of animal torture or killing as an act of domestic violence.

We write to you today to express our sincere appreciation and general support for these important bills. These bills are important because many perpetrators of domestic violence use the threatened or actual secreting, torture, and killing of family pets as a means of controlling their spouse or child victim.

Our section currently includes over 161 members. Our Section council that includes 15 members unanimously voted to support this bill as it progresses through the legislative process provided that one amendment is included. We would request that the word "solely" in section (1)(J)(iii) of HB 4741, be amended to read "solely or jointly." In many cases, a victim of domestic violence must leave the marital home that is jointly owned by the parties. This suggested modification would allow the victim to remove the family pet from the jointly owned marital residence.
