Murphy v Inman:

The Michigan Supreme Court issued its decision in *Murphy v Inman* (case no. 161454), 2022 WL 1020127 on April 5, 2022. At the invitation of the Michigan Supreme Court, the Business Law Section and the Litigation Section submitted amicus curiae briefs.

The Court unanimously adopted the positions that the Business Law Section and the Litigation Section advocated in their respective amicus briefs. In this cash-out merger case, the Court's key holdings include:

- Corporate directors owe direct, common-law fiduciary duties to shareholders that were not abrogated by the adoption of the Michigan Business Corporation Act.
- The distinction between direct and derivative claims is determined by a two-step analysis: (a) who suffered the alleged harm; and (b) who would receive the benefit of any recovery or other remedy. See *Tooley v Donaldson, Lufkin & Jenrette, Inc*, 845 A2d 1031 (Del, 2004).

The members of the Amicus Committee were Douglas Toering, Ian Williamson, Justin Klimko, Marguerite Donahue, Michael Molitor, William Horton, Jennifer Grieco, and Brian Markham. Hon. Christopher Yates also served on the committee in an advisory capacity.

Soaring Pine Capital v. Park S. Group:

The Michigan Supreme Court ("Court") has invited interested groups to move the Court for permission to file briefs amicus curiae on, among other issues, "whether a usury-savings clause is void as a violation of public policy" in *Soaring Pine Capital Real Estate and Debt Fund II, LLC v. Park Street Group Realty Services, LLC*, SC: 163320 (March 18, 2022). If usury savings provisions – common in all transactional documents – were invalidated by the Court, it could have a tremendous impact on business transactions in Michigan.

The Business Law Section has approved the filing a motion for permission to file an amicus brief ("Motion") with the Court to support the enforceability of usury-savings clauses. The committee is currently working on drafting and filing the motion and the brief.

Michigan Uniform Commercial Real Estate Receivership Act:

The Debtor/Creditor Rights Committee has been actively involved in the development of revisions to the Michigan Uniform Commercial Real Estate Receivership Act ("Receivership Act") that would apply to operating businesses and the UARA. The UARA was recently adopted by the Michigan legislature.

Business Corporation Act and Limited Liability Company Act:

The Corporate Laws Committee monitors legislation that could affect Michigan corporation law. The committee has begun the process of assembling material for the next round of amendments to the Michigan Business Corporation Act. The Committee determined to bifurcate that effort and to first focus on preparing proposed draft benefit corporation legislation. That effort is in process. A subcommittee has been established to prepare a draft of proposed legislation, which has met several times and exchanged draft proposals and comments.

The committee assembled a study group to examine the oppression provisions of both the Business Corporation Act and the Limited Liability Company Act., to consider whether changes should be recommended to make it easier to understand and apply. The task force met sporadically for over two years. The task force created subcommittees to study discrete issues arising with regard to the oppression statutes which conferred separately and produced discussion material and recommendations to the larger group. The committee determined to explore whether the business court judges would be interested in amendments giving them expanded abilities to enter preliminary orders in oppression cases and sent a letter to them.

Michigan Business Law Journal.

The Section publishes the Michigan Business Law Journal three times each year in conjunction with the Institute of Continuing Legal Education. Each issue of the Michigan Business Law Journal has a different primary, legal theme focused on articles related to one of the standing committees of the Business Law Section, although the section welcomes articles concerning any business law related topic for any issue. The primary themes of the issues of the Michigan Business Law Journal published (or to be published) during the 2021-2022 bar year were: UCC Committee (fall 2021), Commercial Litigation Committee (spring 2022), and LLC & Partnership Committee (summer 2022). The Michigan Business Law Journal is sent to section members via U.S. mail and electronically, and is posted on the section's website.

Section Strategic Plan/Survey

The activities of the Business Law Section and its council are guided by the section's strategic plan. The current plan, adopted in March 2017, articulates the mission and goals of the section. The plan was adopted with the idea of being revisited and refreshed every five years, and this is its five-year anniversary. The section has formed a committee, chaired by Michael Khoury, to take on that task, and the committee has conducted its first meeting.

In addition, the section will be sending a survey to our members, to help assist and inform the strategic planning process.

Please describe any current public policy activities, any activities completed since September 30, 2021, and any activities planned between now and September 30, 2022.

On February 8, 2022, the Legislative/Rules Committee provided recommendations to the the legislative Joint Committee on Administrative Rules on the Marijuana Regulatory Agency's (now Cannabis Regulatory Agency) proposed Marihuana Rule Set (draft Administrative Rules 420.1 to 420.823).

On February 16, 2022, the Legislative/Rules Committee provided recommendations to the Marijuana Regulatory Agency (now Cannabis Regulatory Agency) on the agency's proposed Industrial Hemp Rules for Marihuana Businesses (draft Administrative Rules 420.1001 to 420.1003b).

The section developed a scholarship program in memory of former council member Allen Peisner. A scholarship will be awarded in his name for each section event that has a fee for members. One was granted for both the Spring Training event and three will be granted for the upcoming Annual Conference to include lodging and travel costs. Ongoing work is being done to raise funds aimed at assisting new attorneys to gain the requisite knowledge to develop their law practice in the cannabis space.

The section will collaborate again with the MI Association of OWI Attorneys to provide a two-day training seminar in September.

HB5117 Estates & Protected Individuals Code, Funeral Representative: Oppose with recommended amendments. The Elder Law & Disability Rights Section of the State Bar of Michigan opposes House Bill 5117 with the recommendation to amendment to more clearly define "good faith effort" on page 5 lines 2 and 3 and to reconcile the conflicts between the time frames that an individual is notified and required to act or decline to act on pages 4 line 26 and 5 lines 4-8.

HB5751 Regulate the Certification of a Person with a Disability's Need for an Emotional Support Animal. Oppose: The Elder Law & Disability Rights Section opposes HB 5751 because it does not comport with current HUD regulations, creates a too-narrow definition of doctor-patient relationship for tenant applicants, and ignores non-ESA assistance animals, creating an unfair barrier for individuals with mental or psychological needs.

HB5758 Estates & Protected Individuals Code, Allowing Electronic Signing.

Support: The Elder Law & Disability Rights Section of the State Bar of Michigan supports House Bill 5758, as written.

HB5759 Michigan Law on Notarial Acts, Electronic Notarizations.

Support: The Elder Law & Disability Rights Section of the State Bar of Michigan supports House Bill 5759, as written.

SB0033 Public Health Code, Electronic Monitoring Devices. Support in Concept but Oppose in Present Form: ELDRS supports SB 0033 in concept for allowing electronic monitor devices in nursing homes as resident rights but ELDRS opposes SB 0033 in its present form as it is substantially unchanged from 2020's final version of SB 0077 regarding cameras in nursing homes. SB 0033 does not allow for the effective use of cameras in residents' rooms or for such video recordings to be used as evidence in a court proceeding. In its present form, SB 0077 better serves the nursing home industry than the residents.

SB0315 Uniform Securities Act (2002), Certain Account Disbursements.

Oppose: The Elder Law & Disability Rights Section of the State Bar of Michigan opposes SB-0315, as passed Senate, September 14, 2021, based upon its lack of due process and the overbroad nature of setting the bright line age of 65.

The section took the following positions on legislative bills and resolutions:

1. HBs 5191, 5192, 5193, 5196. These bills involve modification of statutes that need updating regarding gender neutral language, including statutes in the "secret marriage act," deletion of language barring recognition of same-sex marriages, the UCCJEA, and other statutes to be consistent with Obergefell. The section voted to support these house bills.
2. HB 5340. The section opposed this bill regarding family treatment court due to a lack of judicial discretion contained within the draft of the bill.
3. HB 5368. The section opposed this bill which would require an individual's date of birth to be included in publicly accessible "personal identifying information" in court proceedings.
4. HB 5443. The section opposed this bill which would substantially alter the way a bond is set for child support and spousal support contempt enforcement proceedings.
5. HB 5459, 5460. The section opposed these bills which would mandate equal parenting time and joint custody in all family law cases, which could only be rebutted by a showing of clear and convincing evidence that this is not in the best interests of the child(ren).
6. HB 5464. The section opposed this bill which sought to make food assistance benefits contingent on an individual's "cooperating" with the child support enforcement program.
7. HB 5758, 5759. The section supported these bills which made electronic signing, witnessing, and notarization of documents more permanent by eliminating sunset provisions.
8. HB 5860, 5861. The section opposed these bills which would mandate a percentage share for a father to pay health insurance premiums and hospital/birth expenses in child support cases. The Michigan Child Support Formula already governs the calculation of these expenses on a scale that accounts for "family income" and "ability to pay."
9. SB 856, 857, 858. The section opposed these bills due to the potential for abuse and overly-broad application in divorce or family court proceedings. Also, the existing PPO statute covers many of the problems this bill seeks to solve.

10. SJR J. The section opposed this resolution because there is vague language with respect to what is meant in the resolution by the "best interests of a child." There is not one single statutory definition of the "best interests" of a child. The child custody act contains a "best interests" standard for both custody decisions and parenting time decisions. There is also a "best interests" standard in termination proceedings. The resolution did not make a specific statutory reference to which standard this would apply.

The Family Law Section filed amicus briefs with the Supreme Court on three different cases and has a pending request to file a brief on a fourth case.

Through the Legislative Committee, the Family Law Council voted to approve language for a Premarital Agreement Act that closely follows the existing Uniform Premarital Agreement Act (UPMAA). The alterations from the UPMAA include: (1) language consistent with, and codifying, Michigan case law within the *Allard v. Allard* decision; and (2) modifying the language on waivers to require the waiver be more conspicuously displayed.

Honorable Jon A. Van Allsburg (20th Circuit) was awarded the Marilyn J. Kelly Award for Outstanding Judicial Service in Family Law.

Attorney James J. Harrington III (Novi) was awarded the Norman Robbins Lifetime Achievement Award for dedicated service to the family law community.

Gail Towne (Kalamazoo), a Family Law Council member, was named to Michigan Lawyer's Weekly "most influential women in the law for 2022."

The late Robert C. Treat Jr. was awarded (posthumously) the Blaine Johnson Award at ICLE's 2021 Family Law Institute for significant contributions to continuing legal education in the family law community.

The Family Law Journal published 10 editions through this fiscal year, with each edition including topics such as legislative updates, an article focusing on domestic violence issues in family law cases, case summaries for appellate decisions, and other cutting-edge articles on family law practice and legal developments.

The Family Law Section is seeking to collaborate with the Children's Law Section on a number of legislative proposals that would improve the practice when domestic law and children's law issues intersect.

A Guardian Ad Litem Committee was established to update the practice, training, and resources for family law practitioners who serve as a guardian ad litem in a custody/domestic relations matter.
