2003-2004 ANNUAL REPORT STANDING COMMITTEE ON JUDICIAL QUALIFICATIONS

The Judicial Qualifications Committee interviews, evaluates and rate candidates for appointment to judicial vacancies as requested by the Governor, and reports its evaluation in confidence to the Governor. A representative from the Governor's Office is present during the interview.

Prior to the interview, the application is assigned to one member of the Committee who contacts lawyers in the community to obtain background information regarding the candidate. These sources are confidential.

A representative of the Attorney Grievance Commission is present who has contacted local judges to obtain background information to report to the Committee and any grievances that may have been filed against the candidate.

Activities

The Committee met on nine occasions from May 2003 to May 2004 to interview 160 candidates for the following vacancies:
